Term and Conditions

1. Rice Lake requires that the rental weeks be determined and scheduled at time of order. This allows Rice Lake to make rental commitments for all rental inventory. Any rental units that are kept longer than the agreed upon schedule will be accessed a \$100 per week fee unless prior arrangements are made and agreed to by both parties in advance of the extension.
2. The minimum rental period is 4 weeks.
3. A deposit equal to two weeks rental is required at time of order.
4. The renter term will start when the rental unit ships from Rice Lake WI.
5. The rental term will end when the carrier shows the equipment has been delivered to Rice Lake.
6. Lessee is required to submit a credit application to Rice Lake's Financial Services team if they don't already have an open account in good standing.
7. Rental charges will be invoiced in full when the equipment is returned to Rice Lake and its condition is evaluated.
8. Lessee is responsible for all duties, freight, taxes and brokerage fees.
9. Lessee is responsible to have insurance on all rented units and should list Rice Lake Weighing Systems as title holder; Rice Lake should be named as "additional insured."
10. The iDimension Keyboard Wedge integration tool is available as a free download from www.ricelake.com/software. This program is well documented and easy to use.

11. The iDimension QubeVu Manager supports a REST API command set for network integration. Documentation for the REST API commands is available from www.ricelake.com/manuals.
12. For assistance integrating the rental equipment to your ERP or WMS systems please email iDim_Support@ricelake.com. Integration services are billable at \$145.00/hr.
13. If a more advanced integration is required, please inquire about purchasing a copy of iDim SS (software suite) at iDim_sales@ricelake.com.
14. Delivery address and contact information. The lease equipment identified above will be delivered by common carrier and used at the following address:
15. Upon receipt of rental equipment, the Lessee has a duty to inspect the equipment for damages and immediately contact iDim_Sales@ricelake.com within 3 days to report any issues. Lessee agrees to use the equipment in the manner in which it was intended and is responsible for any abuse or damage during the rental period.
16. An RMA was supplied at the time of order. This RMA must be used when returning the equipment to Rice Lake. Failure to include the RMA with your return shipment may cause the rental term to continue and the rental equipment may become lost. Lessee will be responsible for the full retail price of the rental equipment if some or all of the equipment becomes lost or damaged.
17. Any modifications made to the dimensioner may result in additional charges in order to get the system back to its original state.
18. Equipment must be returned in the original packaging. If the packaging is lost, you can order replacement packaging from iDim_Sales@ricelake.com. Replacement packaging is \$130.00 plus freight. If equipment is returned without original packaging, you will be charged for the replacement packaging and any damage to the equipment.
19. Option to purchase. Lessee can purchase equipment at any time during the rental period. A maximum of 6 weeks rental charges can be applied to this purchase. The purchase price is identified in Table 1. If Lessee chooses to purchase rental equipment, a new two-year warranty will apply from the original date of shipment from Rice Lake, WI.
